- 4. Maximum Age of engagement: No engagement or extension beyond 62 years
- 5. Prior work Experience:
  - a) Minimum 10 years of experience in pay level 6 or above of 7<sup>th</sup> CPC (or equivalent scale), in Sr. Secondary residential school of Central/State Govt./Autonomous organizations of Central or State Govt./ Defence establishment.
  - b) Ten months (excluding vacations) with usual breaks in a year shall be considered as one year for purpose of determining experience.
- 6. Health/Fitness Requirement: As per NVS norms i.e. applicable for regular appointment.

- **8.** Shared single accommodation inside JNV campus only provided.
